   Mr. Jones called the meeting to order at 4:33PM.
- 2. Approval of August 17, 2023 Minutes

3. Review of Budget/Timeline – Fire Station 340

Ms. Massa reviewed the budget and noted that it is unchanged.

3a. Update on the foundation timeline

Ms. Massa provided an update on the foundation.

She reviewed the issues and remediation being done. Structural engineers at CHA are monitoring the work on the foundation. She has requested that CHA certify the foundation as being structurally sound and that there will not be any long-term issues once the repairs are completed. She noted that the footings are fine.

Mr. Jones added that Mr. Paquin has been monitoring the work regularly and will continue to do so as well as do the final certifications.

In regard to the timeline, Ms. Massa noted that at this time the project is still on track but noted that there may be a delay of the delivery of the wall panels due to an issue where the

panels are painted. Where the repairs have been completed, the insulated panels are being installed and all is going well. Additionally, the contractor is working on the under-slab plumbing and running conduits. It is expected that the replacement of the septic tank will begin soon, and the building steel will be put up at the end of October.

### 4. Discussion regarding rescheduling October meeting

A brief discussion took place.

The October meeting was rescheduled to October 5<sup>th</sup>, 4:30PM.

#### 5. Other Business

### 5a. Update on the bonding for Stations 140 and 440

Ms. Massa noted that on September 12<sup>th</sup> she met with Mr. Foley, Mr. Eaton, Chief Littell, Assistant Chief Dojan, and Fire Marshal DaBica to discuss options for the remaining funds. They will reconvene on September 25<sup>th</sup> to review the fire department's list of priorities for repairs on stations 140 and 440. Once completed, the list will be presented to the subcommittee for approval.

This increased cost for Station 340/440 is in line with these typical construction increases. CHA has not increased our fees to reflect the current costs, but stayed at the 2019 level as our commitment to Tolland.

"The specs required that the metal building has "accreditation" (see below & attached specs). The lowest bidder sent a letter of Request for a Waiver of IAS Accreditation, which may be a more complicated process for the Town and it is not certain if this will add additional costs to the project. This has led to several questions we need to discuss with you. The next lowest bidder did provide a building with the proper accreditation."

  - Scope needs to be revised to fit in our remaining budget of \$1,737,618.33.

  - Significantly higher than original estimated amount for \$20,000.00

    - CHA requests additional items unrelated to the curb (costs for footings) be removed from the costs and be submitted on a separate change order request.
