

General discussion of the plans which were just received ensued. Due to the scale of the drawings, there were questions. Commissioners asked the chair to consult with the VRC and get clarification, specifically concerning the radius of the area, the tree/s to be removed and the VRC desire for material for walkway. The TGHDC chair will report back to the commission.

4.2 Discuss Tolland Green sidewalks

It was verified that the TGHDC is unanimous in our position that we exist to give an opinion when asked, which we were. The Tolland Green is a green space and as such it is not appropriate for it to have a sidewalk. A public Green is a green space. Again, the TGHDC, after much research and angst, came to a compromise position to meet the new proposed idea of a sidewalk on the Green with the recommendation that the travel-way be constituted of a crushed stone material. The commission offered several examples that have proven records of durability and weather resistance. At no time has the TGHDC tried to be negative or obstructive, rather render our advice and adapt to the conditions. Conversations at other town meetings have portrayed the commission in a negative light and we wish to clarify the record. (One such meeting was the ARPA meeting on 5/15).
