Tolland Conservation Commission (TCC)

Meeting minutes 11 April 2024 at 7:00 p.m. Virtual meeting via Zoom

1. Call to order 7:04 p.m.

2. Roll call

6. New Business

6.0 Approval of Head Steward

A motion was made by A. Grossman, 2nd by G. Koss to approve the appointment of Ryan McCann as Head Steward of the Conservation Corps. The motion was unanimously approved.

6.1. Next Property for Timber Harvest

D. Corcoran stated that \$15,000 remains allocated for this fiscal year.

- Campell and Stoppleworth properties are potentially the next areas to be harvested. The option of studying other Conservation Areas for potential harvesting was also suggested.
- A discussion followed on the result of the Parciak Conservation Area timber harvest. Concern was
 expressed over the debris left behind. It was decided that each Conservation Commissioner should
 walk the Parciak area to see the results of the timber harvest. Specifically, the blue trail on the left
 at Bald Hill. A walk-thru with the forester and logger will be scheduled if necessary to discuss clean
 up and work needed to be done. A decision needs to be made on the spending of the funds at next
 month's Conservation Committee meeting.
- R. McCann stated that the parking area at Parciak is going to be expanded. The rental of a stump
 grinder and about 15 to 18 yards of gravel is needed. L. A. Swan made and G. Koss 2nd a motion to
 appropriate \$800 for the expanding of the Parciak parking area. The motion was unanimously
 approved.

6.2 Earth Day Activities

A discussion on the commission's Earth Day activity of stenciling of storm drains was held.

- J. Simao stated that she has the stencil and paint.
- The area to be stenciled will be Fox Ridge.
- The date was changed to April 21st.
- J. Simao will send out an email.

6.3 Sixth Grade Field Day at Becker Conservation Area

A discussion on the upcoming sixth grade field day at Becker was held. Tick count and barberry removal will be done. Funds are needed to buy plants. A motion was made by L. Swan, 2nd by G. Koss to allocate \$500.00 from the Material Budget to buy plants for the sixth grade field day. The motion passed unanimously.

- Discussion on continuing the Bigfoot/Unicorn themed activities was held. Specifically, holding monthly scavenger hunts at different Conversation Areas using signs. A. Grossman stated he will investigate the use of QR code technology to help with the hunts. J. Simao will send an email to further plan the scavenger hunts.
- To support future fund-raising events the Commission asked D. Corcoran to talk to the Finance Department on how the commission can accept payments online.
- A. Grossman suggested that the commission consider setting up a Haunted Hike/Trail Walk for October. He stated he will revisit this idea in a few months.

observed on the property which could be of concern. D. Corcoran will relay this information to the
