## DECISION TO ADOYI' RECOMMENDATIONS AND PROPOSED FINDINGS OF SPECIAL COUNSEL AS TO NO PROBABLE CAUSE AND TO DISMISS THE COMPLAINT

On August 24,2022 Complainant, Christina Plourd ("Complainant"), a member of the Tolland Board of Education (BOE) filed a Complaint against Respondents Walter Willett (Superintendent ofTolland Public Schools) ("Willett"), Ashley Lundgren (Chairperson of the BOE) ("Lundgren") and Shipman & Goodwin LLP, counsel to the BOE ("S&G"). On November 8, 2022, Complainant filed an Amended Complaint the allegations of which are directed solely to Willett (the original and amended complaints will hereafter be collectively referred to as the "Complaint"). Respondents were timely notified of the original Complaint (which included documents provided by Complainant under Tabs 1-15) and the Amended Complaint. The Tolland Ethics Commission appointed special counsel pursuant to §6-10 of the Tolland Code of Ethics (the "Code") to investigate whether probable cause exists to believe the Code has been violated and to make recommendations and proposed findings to the Commission based upon such investigation. The investigation is now concluded.

Based upon the results of the investigation and the recommendations and proposed findings of special counsel, which are hereby adopted, the Tolland Ethics Commission finds that there is no probable cause to believe that any of the Respondents violated any provision of the Code and the Complaint is therefore dismissed.

Conn. Gen. Stat. §7-148h, applicable to municipal ethics commissions, inemporates by reference, to the extent applicable, the procedures followed at the state level with regard to the investigation and confidentiality of ethics complaints. More specifically, §7-148h states that the provisions of Conn. Gen. Stat. §I-82a (subsections (a) through (e)) apply to any investigation of an ethics complaint "conducted prior to a probable cause finding, and to a finding of probable cause or no probable cause."

Pursuant to Conn. Gen. Stat. §1-82s(a), (b) md (d), the Complaint itself, the existence of the Complaint, the investigation of the Complaint, this Decision and the recommendations and proposed findings of sp ial counsel are confidential and must be kept confidential. The continuing obligation of the parties to keep this matter confidential extends to any information received or supplied by the Commission (or its special counsel) in connection with this investigEtion whether that information was derived from or provided to Complainant, a respondent, a witness or any other third-party. The disclosure of the complaint, the investigation, the recommendations md proposed findings of special counsel mnd/or this Decision would violate date statute end the rights of the Respondents. The only circumstance under which this matter could be made public would be if sll three Respondents choose to waive confidentbulity in writing. In the event of !Uch a unanimous waiver, notice will be provided to Jill parties. In the absence of such a written wsiver ud notice to an!! parties of same, that confidentiality of the foregoing matter must be stdct y preserved.

In accordance with §1-82a(c), the parties are being provided with notice of the Commission's decision, the findings adopted by the Commission and the reasons for such findings.

## DECISION TO ADOPT RECOMMENDATIONS AND PROPOSED FINDINGS OF SPECIAL COUNSEL AS TO NO PROBABLE CAUSE AND TO DISMJSS THE COMPLAINT

On August 24, 2022 Complainant, Christina Plourd ("Complainant"), a member of the Tolland Board of Education (BOE) filed a Complaint against Respondents Walter Willett (Superintendent of Tolland Public Schools) ("Willett"), Ashley Lundgren (Chairperson of the BOE) ("Lundgren") and Shipman & Goodwin LLP, counsel to the BOE ("S&G"). On November 8, 2022, Complainant filed an Amended Complaint the allegations of which are directed solely to Willett (the original and amended complaints will hereafter be collectively referred to as the "Complaint"). Respondents were timely notified of the original Complaint (which included documents provid,ed by Complainant under Tabs 1-15) and the Amended Complaint. The Tolland Ethics Commission appointed special counsel pursuant to §6-10 of the Tolland Code of Ethics (the "Code") to investigate whether probable cause exists to believe the Code has been violated and to make recommendations and proposed findings to the Commission based upon such investigation. The investigation is now concluded.

Based upon the results of the investigation and the recommendations and proposed findings of special counsel, which are hereby adopted, the Tolland Ethics Commission finds that there is no probable cause to believe that any of the Respondents violated any provision of the Code and the Complaint is therefore dismissed.

Conn. Gen. Stat. §7-148h, applicable to municipal ethics commissions, incorporates by reference, to the extent applicable, the procedures followed at the state level with regard to the investigation and confidentiality of ethics complaints. More specifically, §7-148h states that the provisions of Conn. Gen. Stat. §1-82a (subsections (a) through (e)) apply to any investigation of an ethics complaint "conducted prior to a probable cause finding, and to a finding of probable cause or no probable cause."

Pursuant to Conn. Gen. Stat. §1-82a(a), (b) amd (d), the Complaint itself, the existence of the Complsint, the investigation of the Complaint, this Decision mnd the recommendations and proposed findings of special counsel are confidential and must be kept confidential. The continuing obligation of the parties to keep this matter confidential extends to amy information received or supplied by the Commission (or its special counsel) in connection with this investigation whether that Information was derived from or provided to Complainant, a respondent, a witness or mny other third-party. The disclosure of the complaint, the investigation, the recommendations mnd proposed findings of special counsel mnd/or this Decision would violate state statute and the rights of the Respondents. The only circumstance under which this matter could be made public would be if 2nthree Respondents choose to waive coilfidentislity in writing. In the event of such a unanimous waiver, notice will be provided to 211 parties. In the absence of such a written waiver &nd notice to mp pmrties of same, the eonfidentiality of the foregoing matter must be strictly preserved.

In accordance with §1-82a(c), the parties are being provided with notice of the Commission's decision, the findings adopted by the Commission and the reasons for such findings.
