*Tolland Fresh* provides \$20 vouchers to income-eligible residents to use at local farms for fresh produce. Participating farms submit the redeemed vouchers to the Town for reimbursement. This is the program's sixth year, and it has been a great success! Funding is provided by the Tolland Human Services Department.

- 1. Call to Order: S. Lundgren called the meeting to order a 7:00pm
- 2. Seat Alternate: no alternate was seated
- 3. Public Participation: Brenda Falusi
- 4. Additions to Agenda: Farm stand Regulations, Idea of Tolland Ag Commission sponsoring Regional Ag Meeting
- 5. Old Business
  - 5.1 Campbell Farm- Renter (Jack) resigned the lease for another 5 years. D. Corcoran was able to get a quote for possibly putting a well on the farm. Quote- \$9,000, plus additional costs of \$5,000 for pump and tank. D. Corcoran will look into Farm grants available. Idea of possibly using a water truck for water service for this growing season. K. Murray will connect D. Corcoran with the CT Dept. of Ag. to look into other resources available.
  - 5.2 Agri-Tourism/Social Media Planning- Ag. Commission would like to work on promoting Agri-tourism and our local farms this year. B. Falusi will assist the commission with social media posts, using TFAN and Tolland Tourism. She will work on getting Instagram posts for Tolland Tourism. Commission would like to promote individual farms and farm stands. Commission will work on updating present farm list.
  - 5.3 Farmers Market- B. Foley discussed bringing Farmers Market back to the Tolland Green. B. Foley has been in discussions with present Market Master to move the market back to the green. He proposes have a committee composed of the Market Master, PCC and Agriculture Commission to work on the committee. Date and time

of market to be determined. Market will consist of Farmers, bakers, crafters, and other business and groups in Tolland.

- 6. New Business-
  - 6.1- Farm stand- Resident had inquired about rules of a farm stand. Resident will be directed to D. Corcoran in planning and zoning concerning the rules.
  - 6.2- S. Sullivan proposed Tolland a Regional Agricultural meeting this April. Committee agreed it would be a good idea. S. Sullivan will reach out to surrounding towns to see if here is an interest.
- 7. Other Business- Staff or Commission Members-
  - 7.1- Correspondence regarding small stock- Agricultural commission received an email wanting to change the regulations of land size for small stock animals. This was revised recently by the commission following the state guidelines and adjacent town's regulations. The commission does not feel at this time that the regulations need to be revised again.
- 8. Approve Minutes- November 7, 2022 Regular Meeting. S. Lundgren extended the motion to approve the minutes, K.Molloy made the motion, S. Sullivan second the motion, All in favor.
