**TOLLAND TOWN COUNCIL – ARPA SUBCOMMITTEE MINUTES**  
**ZOOM ONLY MEETING**  
**January 26, 2023 – 4:30 P.M.**

**Committee Members present:** Colleen Yudichak, Chair (C); Tammy Nuccio, Vice Chair (VC); Brian Foley, Town Manager; Lisa Hancock, Secretary

**Others present:** none.

**1. Call to Order**

The meeting was called to order at 4:32 PM by C. Yudichak.

**2. Public Comment**

There was no public comment.

**3. Approval Of Minutes**

B. Foley motioned to approve the Meeting Minutes of December 28, 2022. Seconded by VC Nuccio. Motion carried unanimously.

**4. Old Business – Action/Discussion Items**

**4.1 Report from Town Manager on Soccer Field Status.**

B. Foley stated that the project is moving along and that the drainage is being worked on. There will not be any need for ARPA funds. He also updated the committee on the baseball/softball field needs. He said that he is working together with the leagues to determine a list for a request of ARPA funds.

**5. New Business**

**5.1 Update on Public Works Vehicles.**

VC Nuccio asked if the Town Manager had an update on the need for two trucks. B. Foley stated that he still has to get a study completed to review the actual needs of the entire Public Works operation. He stated that at some point we will need to replace the trucks. VC Nuccio is concerned about purchasing two trucks within the same year because when it comes time to replace them in future years ARPA funds will not be available. C. Yudichak proposes that we push one of the trucks out to year two in order to stagger the purchases. VC Nuccio agreed with this idea. L. Hancock stated that as long as the commitment for the second truck is made before December 31, 2024 then we can still request funds in the FY 2024-25 budget and commit at that time. B. Foley motioned to approve the recommendation of using ARPA funds for the Capital Plan for one truck in FY 2023-24. Seconded by VC Nuccio.

## **5.2 Update from Grants/Projects Manager on the jailhouse ADA ramp.**

B. Foley advised that all the required information has been sent to the State SHPO in order to work on an RFP for an Architect. The Town is awaiting a response from SHPO.

## **5.3 Discussion of a more transparent way of how we are using the funds on the website.**

C. Yudichak discussed getting information onto the Town's ARPA website page. L. Hancock mentioned that putting the spreadsheet up every time it was updated would be cumbersome and require a significant amount of staff time. She recommended that we prepare a list of all the approved requests and put those on the website. Everyone concurred. B. Foley stated that he will have staff update the website after each ARPA meeting.

## **5.4 Review of the spreadsheet and any discussion of adding or removing items.**

The committee reviewed the spreadsheet. VC Nuccio discussed the veteran's memorial project. She recommends that a community share of the project style be used for this project. It would include possible fund raising on the part of the community and Veterans Commission along with a request for matching funds from the sustainable cities grant program. Then after that there could be a consideration for the use of ARPA funds. B. Foley will reach out to the Veterans Commission to discuss.

L. Hancock discussed the status of the Forest Management request from the Conservation Commission. She spoke with David Corcoran and he shared that the Commission has been moving forward on the project. He is going to check with Jim Hutton to see if there is still a need for ARPA funds.

L. Hancock discussed the ADA study that she had completed last year which included several high-cost initiatives. That report was also shared with Council. VC Nuccio would like to keep this project on the list for now for possible future consideration of some of the projects. B. Foley noted that there has been some ADA improvements that have moved forward, most notably, the recent Cross Farms ADA improvements. He is also going to be proposing improvements for the Town Green which will fall under this request also. VC Nuccio concurred with the many improvements thus far.

L. Hancock stated that the pickleball courts are included in a future year in the capital plan. B. Foley would like to leave this on the list for future consideration.

B. Foley stated that we can move the Soccer Field improvements to no longer considering because the repairs are underway.

C. Yudichak asked VC Nuccio if she had obtained any information from Vernon for their splash pad project. She stated that they had done some general research and had values for different types of splash pad projects which varied from \$750,000 to \$2.6 million. This project could potentially create a long-term operating and staffing cost for the Town and that would also need to be considered. The committee discussed leaving it on the list for now. L. Hancock also suggested that maybe a band shell be constructed at one of the parks or the Green if that was a desire communicated by the community. However, VC Nuccio mentioned that there does not appear to be a strong demand for it.

#### **6. Adjournment**

L. Hancock motioned for Adjournment at 5.22 PM. Seconded by B. Foley. Motion carried unanimously.

**Dugouts:**

1. They provide protection from the elements: Baseball dugout shelters can protect players and coaches from sun, rain, and wind. This can help reduce the risk of player injuries and improve game quality.
2. They improve team morale: Baseball is a team sport and dugout shelters can help create a sense of camaraderie among players. This can lead to improved team morale and performance.

**Dugout Top:**

Cover existing dugouts that are not currently covered for extra layer of protection from both game and weather elements.

**Weighted Tarps:**

Baseball Tarps are great for preventing your field from getting wet. They are waterproof, so even if it rains on game day there is no need to worry about the players slipping and sliding around in mud. The baseball tarp can be placed over home plate or and pitching mound for added protection during downtime. You do not have to worry about water seeping through since baseball tarps are constructed from heavy-duty vinyl and poly materials that are durable, tear resistant, rot resistant, and mildew resistant while being easy to handle when putting on and taking off the field along with storage.

Baseball Tarps will also help with keeping the dirt and clay in their designated areas helping to keep material costs down and maintenance time to a minimum.

**Fencing for bullpen area**

A bullpen describes the physical area, which is usually enclosed, where relievers warm up before entering games. The fenced in area would provide safety for both players and spectators as they warm up before and during a baseball game.

**Bleachers**

Bleachers will provide parents and other spectators a safe area to gather and watch participants playing at the fields.

Material needed for the dugouts and batting cage area.

I would like to put a request for funding in regards to a portable ice rink in the amount of \$10,000.00. Below you will find an itemized list for the requested funding. The following figures are in line with the purchase made by the Town of Vernon for their portable rink.

### History of Ice Skating

The Town of Tolland had an ice skating area located a Heron Cove in the past (approximately 12+ years ago). The area was an asphalt area that would be flooded and maintained by the Town up until the repairs no longer could hold the water in the area. Approximately 3 years ago, a resident approached the Recreation Department in regards to a portable ice skating rink. The group "Skate Tolland" was formed now has approximately 170 members on their Facebook group in favor of an ice skating rink in Town.

The rink would provide skating for the residents of Tolland from the beginning of December through the end of February/early March (weather and ice conditions permitting).
